
Dear Laura,

BY-LAWS
of
South Texas Chapter
of the

Hudson Essex Terraplane Club, Inc.
Enacted February 7, 1998

ARTICLE I
Name

Section 1. The name of the association shall be **South Texas Chapter of the Hudson Essex Terraplane Club.**

Section 2. It is a chapter of the Hudson Essex Terraplane Club of America and is organized subject to the laws of the association.

ARTICLE II
Objectives

The objective shall be the same as those of the Hudson Essex Terraplane Club of America

~~Section 1. To perpetuate the memory and spirit of those who achieved and built the Hudson Essex Terraplane products of Hudson Motor Car Company.~~

Section 2. To encourage the restoration, preservation of the Hudson Essex Terraplane. To carry products and records of Hudson Motor Car Company and other source material relating to the history of the Hudson Essex Terraplane automobile.

Section 3. The special objective of the South Texas Chapter shall be to further interest in Hudson cars and products.

ARTICLE III
Membership

Section 1a. Any person is eligible for membership showing interest or owning a Hudson motor car product.

Section 1b . Membership eligibility is required to belong to National H.E.T. Club as well as South Texas Chapter of the H.E.T. Club.

Section 2. Any member sixty (60) days delinquent in paying dues to chapter and National H.E.T. Club shall be dropped from membership.

Section 3. Secretary -Treasurer shall keep a strict record of all business transactions of the Chapter as well as all receipts and disbursements. The Secretary -Treasurer shall notify members of unpaid dues; also send a list of newly elected officers to National.

ARTICLE IV

Dues

Section 1. The fiscal year for the Chapter shall be from January 1 to December 31.

Section 2. The annual H.E.T. National and Chapter dues shall be payable in January. A member who has not paid dues shall be denied the privilege of voting and dropped from membership.

Section 3. Dues shall be \$10.00 per family each year, or as levied at the start of the year.

ARTICLE V

Officers

Section 1. The elected officers of the Chapter shall be President, Vice-President, and Secretary-Treasurer. The retiring President shall serve as Parliamentarian.

Section 2. The term of each officer shall be two (2) years and officers may serve more than two (2) consecutive years on the same office.

Section 3. No member may be elected to office until he/she has shown an interest in the organization by paying dues, participating in Chapter functions and attending a reasonable number of meetings per year.

ARTICLE VI

Duties of Officers

Section 2. The duties of the President shall be to preside at all meetings, to enforce all rules adopted by the Chapter, and to call special meetings when necessary. He/She shall appoint committees when necessary and shall be an ex-officio member of said committees, except nominating committees.

Section 2. The duties of the Vice-President shall be to assist the President when requested and in the absence of the President, to preside.

Section 3. The duties of the Secretary-Treasurer shall be to keep a record of all business transactions, all receipts and disbursements, a current role of dues paid members, honorary member.

Section 3. The duties of the Parliamentarian shall be to direct the Chapter in Parliamentary usage.

Section 5. Retiring officers shall give to their successors all records and any help the newly elected officers shall request.

Section 6. Officers shall be elected in November and take office in the following January.

The South Texas Chapters boundaries will consist of the Southern part of Texas south of US 84/US 87 extending east to the Texas/Louisiana line and west of the Mountain/Central Time Zone line.

Section 5. Retiring officers shall give to their successors all records and any help the newly elected officers shall request.

Section 6. Officers shall be elected in November and take office in the following January.

Our regional would, however, include that portion of the State of Chihuahua, Republic of Mexico that lies within our area.

Local Hudson enthusiasts have been organized for nearly two years now. They are presently known as The Hudson Motor Car Club of El Paso, Texas and prefer to retain this name, as it has become quite well known locally. The Southwestern Regional would be used for purposes of all meets and any references made to us in the White Triangle News. We are familiar with our obligations to the HMT once we have been granted a regional chapter and will certainly meet those obligations to the best of our ability.
